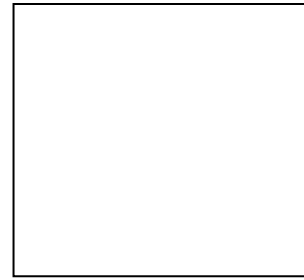

Do hereby solemnly affirm and sincerely state as follows :

(1) I was enrolled as an advocates on ..... and my name is entered in the Rools of the Bar Council of Tamil Nadu in Roll No. Ms. ....

I was enrolled as an advocate in the Hon'ble High Court of Judicature at Chennai on ..... and my name is not entered in the Rolls of Bar Council of Tamilnadu. Hence, I am now filling the Declaration under Section 17 (1) (a) of the Advocates Act. 1961. In proof of my data of birth I am filling my S.S.L.C. Book T.C. / Judicial Officers Gazette etc. together with attested Xerox copy of its relevant page. After scrutiny you may retain the Xerox copy and return the original to me. I am enclcsing crossed D.D. for Rs. 50/- being search charge favouring Secretary, Bar Council of Tamil Nadu.

(2) I suspended my practice by my letter dated ..... To the Bar Council of Tamil Nadu as I entered service/trade/industry.

At the time of Enrolment, I was in service and I filed a declaration of non-parctice with my enrolment application then,

- (4) I had severed all my connection with the trade/industry/business and at present I am neither having any interest nor actively participating in any trade/business or industry.
- (5) I am not in full time or part time service under anybody.
- (6) I have not been convicted of any offence involving moral turpitude and not convicted of any offence under the untouchability Offences Act, 1955.
- (7) I am enclosing a Bank Draft for Rs. 620/- being the life time payment towards Advocates Welfare fund Sponsored by the Bar Council of India.
- (8) I am also filing a Crossed Bank Draft for Rs. 5000/- Drawn in favour of the Bar Council of Tamil Nadu, Chennai being the Resumption charge and a Bank Draft for Rs. 2000/- drawn in favour of the Bar Council of India, New Delhi payable at Chennai.
- (9) I hereby undertake to comply with the following rule framed by the Bar Council of India.

RULE 7 :-

“ An Officer after his retirement or otherwise ceasing to be in service shall not practice for a period of two years in the area in which he exercised jurisdiction for a period of two year in the area in which he exercised jurisdiction for a period of 3 years before his retirement or otherwise ceasing to be in service.

RESOLVED that nothing in these Rules shall prevent any such person from practice in any Court or Tribunal or authority of superior jurisdiction to one in which he held office.

Explanation :- “Officer” shall include a Judicial Officer, Additional Judge of the High Court and Presiding Officer or Member of the Tribunal or authority or such other officer or authority as referred to in Sec. 30 of the Act.

“Area” shall mean area in which the person concerned exercising jurisdiction.”

- (10)I pray that my affidavit may be accepted and I may be allowed to resume practice as an advocate early with your permission.
